## The Benefits of Your **Involvement in NSNA and NJNS**

Joining the National Student Nurses' Association (NSNA) is more than paying membership dues. Membership in NSNA also includes a membership in the state level pre-professional organization, New Jersey Nursing Students, Inc. (NJNS). Belonging to both the national and state organizations provide an opportunity to develop the skill of professionalism and transition nursing students into their careers.

## NSNA, NJNS, and School **Chapters**

NSNA is a pre-professional nursing organization, representing nursing students at the national level. The

mission of NSNA is to foster the professional development of nursing students. With 60,000 members nationwide, NSNA is the voice of future nursing professionals. Membership in NSNA gives you membership in NJNS. At the state level, NJNS represents over 1,500 student nurses who are enrolled in fortyseven New Jersey nursing schools. NJNS consists of twelve board members, who organize events that promote professional development. These events include the Council of convention that the next NSNA School Participants (COSP) conference in October and the NJNS Annual Convention in February. The local chapters are the individual school nursing student associations. Many school chapters hold events related to networking, education, and philanthropy. One of the most important responsibilities of school chapters is to send delegates to the annual NSNA and NJNS conventions.

## Benefits of NSNA Membership

NSNA membership provides benefits at both the national and state level, which include mentorships, socialization, and networking. These benefits can facilitate the employment process for nursing students since they can meet professionals established in

various nursing specialties. Moreover, nursing students can include their NSNA membership on their resumes, which can highlight their involvement in nursing beyond the classroom. Members can get involved by attending events hosted by NSNA or NJNS such as conventions and conferences. This year, NSNA members from across the country will attend the national NSNA convention at Disney in Orlando, Florida. It is at the national board is elected by state and school delegates. ## Benefits of NJNS

In New Jersey, nursing students, not limited to NSNA members, can attend the state NJNS Annual Convention in February. It is at the state convention that the next NJNS board is elected by school delegates. Only NSNA members

are eligible to run for a NJNS board position, serve as a delegate or monitor, or apply for a NJNS scholarship. Delegates and monitors' convention fees and monitors' hotel rooms are paid by NJNS. NSNA members who are not attending as a delegate or monitor receive a discounted convention rate. Information about running for a NJNS board position, serving as a delegate or monitor, and applying for a scholarship are located on the NJNS website. Scholarship winners will be announced at the convention.

## Benefits of Professional Nursing **Organizations**

NSNA also facilitates the student nurses' transition into professional nursing organizations such as the American Nurses Association (ANA). ANA represents the interests of registered nurses across the United States through advocacy in Congress and the development of standardized credentialing guidelines. This organization unites registered nurses and promotes quality health care. It advances the nursing profession by fostering high standards of nursing practice, promoting a safe and ethical work environment, bolstering the health and wellness of nurses, and advocating on healthcare issues that affect nurses and the public.

## **New Jersey Faces Worst Measles Hit in Decades**

Measles vaccines have risen over the past year, totaling to approximately 1,250 reported cases from January 1<sup>st</sup> through October 3<sup>rd</sup>, 2019 from the Centers for Disease Control and Prevention (CDC). This is the highest reported number since measles was declared eliminated in the United States since 2000. Epidemiologists found transmission of this deadly virus in New York State, Washington, California, and New Jersey.

Measles is a highly contagious disease, which can cause not just skin rashes and a high fever, but also pneumonia, seizures, and death. The CDC reports, "one out of every 1,000 measles cases will develop acute encephalitis" and "one to three out of every 1,000 children who become infected...will die from respiratory and neurologic complications."

All 50 U.S. States require that children have to be vaccinated in order to attend public school; New Jersey is one of the 47 states that allow exemptions based on religious or philosophical beliefs. A

Drexel study published by the American Public Health Association revealed that New Jersey (and New York) had the most anti-immunization bills proposed in their state legislatures from 2011-2017, totaling to 29 bills followed by New Jersey (28), West Virginia (15) and Mississippi (12). However, the problem is much more than policy. We are seeing a reform and establishment of misappropriation of human rights relating to vaccinations. While American privilege, opportunity, and freedom of personal choice are all essential virtues, we've lost the focus which is to protect our children and to protect our community.

Areas including Ocean County are the major anti-vaccine hotspots due to the nonmedical vaccine exemptions unrelated to religion. Vaccination coverage has dropped thus weakened entire population "community immunity." Public health experts recommend 93%-95% of population vaccination in order to achieve this level of immunity and ensure adequate coverage.

The anti-vaccination movement against measles was ignited when English physician, Andrew Wakefield, published a paper in 1998 suggesting the unsafe administration of the measles vaccine and its link to autism. Many research studies have been conducted to assess the safety of the MMR vaccine. A met-analysis by Taylor, Swerdfeger, and Eslick (2014) found no link between the vaccine and autism.

Although the Wakefield's paper has since been retracted from the *Lancet* journal, the damage was already done. The media has

already seized the story and caused a rampage of public fear and confusion over the safety of the vaccine.

The good news? These vaccines are email me at highly protective; only two doses are required for long-lasting protection (NHS, 2018). It is up to us as aspiring nurses, current healthcare providers, and health advocates to help reframe the narrative. We should aim for 100 percent vaccination coverage over the broad range of demographics, especially those children born from immigrant families. More studies are needed to determine the impact of outreach programs for immigrants.

Local health departments are working diligently to promote prevention strategies and initiate outreach programs into these communities in hopes of stopping the outbreak for good. In addition to local level initiatives, Population and Global Health Sector of the New Jersey Nursing Students, Inc. (NJNS) for the 2019-2020 term is taking lead in helping increase vaccination rates in the state of New Jersey.

# Diversity through a Futuristic Lens

The theme of 2020 New Jersey Nursing Student Inc. (NJNS) convention is "Power of the Past, Force of the Future: Through a Diverse Lens". As the resolutions director, I chose a topic that looks at diversity through a futuristic lens. For my resolution, I decided to address the physical health of those with severe mental illness and the influence healthcare professionals have on the outcomes of these patients. A severe mental illness significantly impacts one's ability to perform everyday life activities. Disorders such as severe bipolar disorder or schizophrenia are classified as severe mental illness. This topic is related our convention theme of diversity. Diversity is a term used when talking about race, culture and gender. Diversity can also be related to cognition and abilities.

For my resolution, I decided to talk about the role healthcare professionals have in the physical wellbeing of those with serious mental illness. I chose this topic because I recently discovered a study that stated those with severe mental illness die on average 10-20 years earlier than the general

population (Liu et al.,2017). This made me think, what role do nurses and other healthcare professionals play in this huge health disparity? My next question was, is there mental health stigma among healthcare professionals? I discovered a practice that is detrimental to not only those with severe mental illness, but to those who suffer from any type of mental illness. The practice of diagnostic overshadowing is when a nurse, physician or any healthcare provider who is assessing the patient misattributes the patient's display of physical symptoms to be a result of their mental illness. For example, a physician may attribute a rapid heart rate to anxiety rather than a cardiac issue. This can lead to a delay in diagnosis and treatment for those who actually suffer from a physical ailment. When a healthcare professional diagnostically overshadows a patient's true condition, this often leads to a decline in quality of care for patients and poor patient outcomes.

The health disparities that people with severe mental illness face are a result of complex factors and these factors are at the individual, community and health system levels. I want to increase nurses' awareness of this problem so they can care for and advocate for their patients. Through education and the use of evidence-based practice, nurses can make a difference in the mortality rate of those with severe mental illness.
